I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 27/07/2017 considered the Compliance Verification Assessment Report (13.01.2017) along with the Council Assessor's Report (May, 2015 & 04.03.2016) and compliance dated 06/06/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification for 04 seats at Muzaffarnagar Medical College, Muzaffarnagar granted by Ch. Charan Singh University and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (13.01.2017) along with the Council Assessor's Report (May, 2015 & 04.03.2016) and compliance dated 06/06/2017 submitted by the college authorities and decided to recommend to the Central Government that MD(Pathology) qualification for 04 seats granted by Ch. Charan Singh University in respect of students being trained at Muzaffarnagar Medical College, Muzaffarnagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Greetings from the Postgraduate Medical Education Board (PGMEB) of the National Medical Commission (NMC). With reference to subject noted above for the recognized postgraduate qualifications which were done under following inspection types:

1. Recognition of PG Course
2. Recognition against increased intake of PG Course, and
3. Renewal of Recognition of PG Course

As per Postgraduate Medical Education Board (PGMEB), it has been decided that recognized PG Courses shall be extended for another One (01) year when those are granted by their specific University (in which the PG Course is running under or granted) for the academic year 2020-21 and shall be valid for a period of 01 year or for a period as notified by the National Medical Commission, whichever is earlier, from the date of issuance of this letter upon which the institute shall apply for renewal of recognition so granted. **Subject: Regarding availability of 50% Post Graduate Seats in Broad Specialty Medical Courses (MD/ MS/ Diploma) Under "All India Quota" and 100% seats of Central/ Deemed Universities for the year 2022 – reg.**

Dear Sir/ Madam,

National Medical Commission is in receipt of requests from PG Medical Colleges regarding status of recognition/ renewal of recognition of PG Degree/ Diploma courses for which applications were submitted by them during 2022 in order to fill up the seat matrix for All India Quota and State Quota Medical Counselling. The applications submitted for recognition/ renewal of recognition of PG Degree/ Diploma Courses during 2022 are under process and will take time.

2. Post Graduate Medical Education Board (PGMEB) in its meeting held on 28<sup>th</sup> June, 2022 discussed the issue and decided that to obliterate the difficulties being faced by the colleges and the students due to non-recognition/ non-renewal of the PG courses in view of the Covid pandemic and related administrative issues, recognition of courses of such colleges/ institutions may be extended by one more year i.e. up till admission for the 2022 batch. However, it will not be applicable in those cases for which any specific order has been issued by Medical Assessment and Rating Board or Post Graduate Medical Education Board for stopping of admission in any specific course.

3. Hence, all Medical Colleges/ Institutions imparting Post Graduate Courses are requested to fill the seat matrix for medical counselling, accordingly.



Post Graduate Medical Education Board (PGMEB) has received 2828 applications from Medical colleges/Institutes for recognition/renewal of recognition of PG Medical qualifications during the year 2022. So far, the Board has taken decision on 1870 applications; and decision on the remaining applications is under process. As the Counselling process on the basis of NEET PG-2023 is going to start soon, therefore, the existing recognised/permitted PG Broad Speciality seats available with the medical colleges/institutes will be considered for admission for Academic Session-2023 and Seat Matrix will be prepared accordingly.
