- 3. Supplementary Tuition fee of Rs. 50,000/- shall be charged from detained and failed students reappearing in supplementary examination.
- 4. Students found in possession of intoxicating substances shall be dealt with strictly and even liable to rustication from the college as well as University.
- 5. The fees to be deposited every year by 31st May in advance for the coming academic year. A fine of Rs. 1000/- per day will be charged after 31st May. Any student whose fee along with the fine imposed on him/her for delayed submission is found to be unpaid will be suspended from attending lecture/practical classes.
- 6. Medical Checkup, University Examination Fee, Registration etc. will be charged extra.
- 7. After completion of PG Course, one year SR Ship is compulsory in concerned department. Salary will be effective as per prevailing rate.
- 8. In view of same fee structure fixed by Fee Fixation Committee, Government of Uttar Pradesh since Year 2021, Institute has applied a plea (Writ petition C-No. 8277/2025) for increase of fee to Hon'ble High court, Therefore all the students have to be submitting an undertaking stating that "whatever fee is fixed by the Hon'ble court for the academic session 2025-2026 (Batch 2025) that fee amount will be deposited to college accordingly".
